I. Call to Order—Jeff Clutter

- **b.** Jeff welcomed Laura Smart, new board member who took Chris Westfall's positions.

II. Approval of June Minutes - Deb Sherwood

a. Deb reviewed minutes. Michelle motioned to accept. Ted seconded. Approved.

III. Treasurer Report—Jennifer Wigginton

- **a.** Received 2 membership fees, sponsorship fee from McGraw Hill, one table sponsor, Indy Reads 2016 conference registration fee, contract labor \$1,038. Expense fees. Paid accountant \$658.75.
- **b.** Need a system for Sara to deposit checks. She's willing to deposit at the TCU near her. In discussion with the accountant.

IV. State AE Update—DWD

- **a.** Grant application to be released soon. Once grant is released applicants will have 4 to 8 weeks to prepare and submit.
- **b.** Announced new partnership with Anthem BlueCross Blue Shield to cover testing for their HIP Plus members. In conversation w/ Anthem re: logistics. A webinar will be set up for test examiners on how to register and take care of the fees.
- **c.** Changes in PD will take place in the February call. State wants more flexibility in leading PD and wants to deliver initiatives more regionally

and locally. RFP was released and rescinded so they could take greater control in leading PD in the state.

- **i.** Jeff asked if it would be state staff leading the PD. Hiring a PD person to oversee? Will Jerry be leading PD?
- **ii.** Jerry commented that he and other staff members will be leading PD.
- **iii.** Michelle asked if waivers could be sent in. Jerry asked to make sure they've done all 10 hours prior to send in.
- **iv.** Natalie asked if they could send in waivers for staff members who could not attend PD because of schedule conflicts/going to school. Jerry asked to have them send it to him.
- v. Jeff asked why AE teachers need to have 10 hours of PD and no teaching certification but k-12 who have to be certified do not need to have that many hours.
- vi. Michelle has all part-time teachers and requires them to do 10 hours of PD. Should she be paying them? Some programs give a stipend for attending conferences, etc. Suggestion for Michelle to check C9 policy re: stipend rate. Jerry mentioned he has seen all 3 throughout the state (nothing, stipend, hourly).
- **vii.** Natalie commented that programs have been talking about providing teacher PD but would like instructional assistant PD.
- **viii.** Jerry asked to send ideas and concerns to him, including unique situations that pertain to programs.
