- **b.** Discussed DWD/IAACE partnership in detail.
 - i. Marilyn Pitzulo attended meeting. A DWD representative is encouraged to join our meetings to report to our group about the monthly WIOA workgroup, SWIC (State Workforce Investment Council), etc.
 - ii. It's important to have a DWD attendee in order for them to be engaged with IAACE activities, etc. They take notes and report back to DWD. They cannot advocate for Adult Ed like IAACE can.

 - **iv.** DWD handles legislation. IAACE can make grass roots legislative efforts.
