- IV. 10:05 am State AE Update—DWD
 - a. Submitted final data for 2018 67.09 Distance 72.68 These are new records for Indiana Enrollment was down to 24,740 from 26,370 the year before. Separation rate has improved 28.29% from 32.37% the year before.
 - b. Nancy shared about Regions performance 2, 11, 5 and 8 had the most increase in enrollment
 - c. 4,1, 6,3 had lowest increase in enrollments
 - d. 9, 10, 11 and 8 for highest in MSG
 - e. 4.2.3.7 was lowest in MSG
 - f. 5, 8, , 9, 3 most increase in HSE
 - g. Lowest in HSE 4, 6, 1 and 10
 - h. Separation rate lowest 9 10 11 8
 - i. 4,3 1 and 6 highest separation

 They lost 600 in enrollment part of our 1600 loss

- V. 10:15 am Governor Cabinet Update-Michelle
 - a. Michelle is on Workforce Development board for Region 5 and had a retreat with Commissioner Payne and DWD's leadership. Learned about Workforce Develop

boards. The Commissioner has met with boards for 1.5 and he is making strategies to align the boards. Marilyn did a great update on Adult Ed. Each DWD department spoke on what everyone is doing. Adult Ed was mentioned several times.

- b. Met with the commissioner this week and we talked about eligible training providers. That policy is up for discussion. We want to have enough qualified training providers. Michelle suggested asking Adult Ed providers we would have some input to help with this. There are listening tours going out and Adult educators should attend.
