ministry to its parishioners. Secondly, if the space isn't possible, maybe the church could simply put a regular announcement in its weekly bulletin about the English language classes you offer.

Adult Education Program Development Goals

We learned in our Adult Education Statewide Class last month that our local program performance goals are:

- 69% or more of our students will make a measurable skill gain (NRS Table 4, Column J)
- Meet or exceed the enrollment goal for your program assigned by DWD
- Increase the number of students earning a high school diploma or equivalent by 10% over 2022-2023.
- 50% or more of our students will have distance learning hours (Total Distance Learning Report)
- Increase enrollment of students in Integrated Education & Training (IET) courses by 10% over 2022-2023. Attain 90% completion of IET courses and 90% certification rate.
- Add 1 Workforce Education Initiative (WEI) with a new employer partner OR add 1 more course to an existing employer partnership.

If any of this is confusing or unclear as a new director, we're here to help! Contact any of the adult education staff, your own program's Professional Development Facilitator, or me. We will be happy to explain what these goals mean and brainstorm some strategies to achieve them.

We Can Get More Money?!

Yes! There are additional funds available for workforce education initiatives over and above the adult education allocation you received for 2023-2024. We want to avoid (1) charging an employer for WEI services we provide, and (2) telling an employer "No" due to lack of funds when they ask for WEI services from us. Are You Current?

Now is the time to make sure that your program's website, social media pages, and fliers are up to date. Things to check: types of classes (English Language Learning, High School Equivalency, etc.), locations of classes, times and days of classes, teachers' names, and how to register (i.e., just show up, call us, online form). Also, take this opportunity to update your program's information in the National Literacy Directory at https://www.nld.org/.

Last Call for Data!

By August 10, we must, must, MUST have all the data in InTERS finished for program year 2022-2023. After August 10, our state staff will be doing data clean-up and getting data ready to submit to the federal government as a final state report. So, by August 10, be sure:

- ✓ All student registrations are in, including demographics and courses,
- ✓ All attendance hours and times are in,
- ✓ All pre-, post-, and HSE tests are in,
- ✓ All students have a focus subject (not blank or "Multiple Subjects")
- ✓ All IET and WEI statuses are updated for participating students: currently enrolled, completed, dropped, and certified, and
- ✓ All errors are corrected to the extent possible.
