An Idea to Increase Enrollments

Are you missing some enrollments and gains because people do one of these:

- Pass the high school equivalency tests without registering for adult education classes ("walk-ins"),
- Get themselves ready in your classes to take the high school equivalency tests and then disappear before testing, or
- Just live in your community without taking classes or the high school equivalency tests?

If you have said "yes" to any of those scenarios, then it could be time to start a "High School Equivalency Bootcamp" or "HSE in a Hurry" type of class. *Such a class is a marketing and recruiting opportunity* to enroll and get gains from people who could pass the high school equivalency tests in a short period of time (like 3 days!) but don't even try to enroll in classes. In the example below, we picked Thursday, Friday, and Saturday because we don't have other classes on



Fridays and Saturdays. Here's one possible model of how it can work using HiSET® as the high school equivalency assessment:

That's just one model. Adult education programs vary in the days of the week they offer HSE Bootcamp, the times to start and end each day, and what subject they do each day. If you give the GED® tests, adjust the subjects and test hours accordingly. The purpose is to offer some to adults who are not approaching in the adult education program already. The main thing to make this help you increase enrollments is to market the heck out of it about a month ahead of time through your referral partners, digital platforms, etc.

But what about the people who come for the "qualifying pre-test" and don't show they're ready to pass the HSE tests? No problem: you invite them to your regular classes. So either way, you'll have more students enrolled, and that's the idea!

Indiana University Indianapolis and Indy Language Center are hosting this two-hour in-person workshop on developing objectives and assessing student and course outcomes in workplace English programs.
